



Teachers' Summer Pilot Program with Mary Kay

DEVOTE:

-5 Hours per week to teaching the product -

2 Hours per week for education and support to learn the products and techniques.

INVEST:

Starter Kit \$100 plus tax & shipping (optional product investment if you want product on hand.)
